ANOTHER ACCOUNTANT WAS ASSISTING THE BRIDGE OF HOPE GREATER DENVER IN PREPARING THE FORM 990EZ; HOWEVER IN THE TRANSITION THE EXTENSION FOR THE 990EZ WAS NOT FILED TIMELY. IN ADDITION, IT WAS DISCOVERED THREE DAYS AFTER THE FILING DEADLINE THAT THE BRIDGE OF HOPE GREATER DENVER WOULD NO LONGER BE ABLE TO FILE A FORM 990EZ DUE TO A \$250,000 DONATION THAT EXCEED THE 990EZ THRESHOLD OF \$200,000. WITH THE NEED TO CHANGE TAX FORMS THE BRIDGE OF HOPE GREATER DENVER IMMEDIATELY REQUESTED ASSISTANCE FROM A CPA TO PREPARE THE FORM 990 AND STARTED GATHERING THE EXTENSIVE AMOUNT OF ADDITIONAL INFORMATION NEEDED TO PREPARE THE FORM 990 AND THE SUPPLEMENTAL SCHEDULES. THE BRIDGE OF HOPE GREATER DENVER ACTED QUICKLY TO CORRECT THE OVERSIGHT AS SOON AS IT WAS DISCOVERED BY FILING ITS RETURN ELEVEN DAYS AFTER THE DUE DATE. THE BRIDGE OF HOPE GREATER DENVER HAS HISTORICALLY FILED ITS RETURNS IN A TIMELY AND ACCURATE MANNER AND INTENDS TO REMAIN IN GOOD STANDING WITH ITS FILING OBLIGATIONS. FURTHER, STEPS HAVE BEEN TAKEN TO ENSURE THAT ALL FUTURE FILINGS WILL BE FILED ON A TIMELY BASIS. THEREFORE, WE RESPECTFULLY REQUEST THAT YOU WAIVE THE PROPOSED PENALTIES.
