1 Briefly describe the organization's mission.

Neighbor 2 Neighbor (N2N) provides the homeless in the Pendleton area with warm and safe overnight accommodations within a quiet and welcoming atmosphere from November 15 through March 15 when the potential for hypothermia is elevated, and periodic shelter services at other times. N2N furnishes homeless and other needy individuals basic sustenance in coordination with other local charitable organizations. N2N supports the homeless in their efforts to end their homelessness.

Operation of Pendleton Warming Station:

The Warming Station provides nightly temporary accommodation for homeless when over night temperatures are below 32 degrees. The Warming Station was open 121 days between November 10, 2018 and March 15, 2019. A total of 152 homeless individuals stayed at the warming station. Total visits to the station during this period was 2467. The average guest count was 20.4, with the highest occupancy of 34 and the lowest 6. The Warming Station was generally open from 1830 to 0600 the following morning. Evening meals were served as well as a small breakfast. Showers were also provided in the facility. At total of 164 laundry vouchers good at a local laundromat were provided, as well as used clothing/footwear that is donated from time to time. Neighbor 2 Neighbor is comprised entirely of volunteers. Sixty volunteers ran the warming station during this year and contributed a total of over 2500 hours of service.

Operation of Pendleton Day Center:

The Day Center provides homeless individuals shelter from the elements during selected hours of the day when temperatures are extremely cold or extremely hot. The Day Center was also open periodically during the day for showers, laundry vouchers and other services to homeless individuals. The Day Center provided short-term motel lodging for homeless with special needs, such as illness or when with small children. Three individuals received lodging, approximately 25 laundry vouchers were provided; and approximately 20 showers were provided. No other statistics were maintained.

Veda's Breakfast:

Veda's Breakfast was served every Sunday during the reporting period between 0800 and 0900 in the basement of the First United Methodist Church. However, due to losing a location to conduct the operation, Veda's Breakfast was discontinued in May 2018. It is hoped that Veda's Breakfast will resume in fall 2019.
