Grantmaker's Description of How Grants are Used	Participants who are moving out of homelessness and other crisis situations into affordable housing are referred to greeNest by various agencies in the area who determine that individuals are in need of home furnishings. The agency and/or the participant pays greeNest for a specified point value of furnishings to be selected by the participant. The participant then selects furnishings from the warehouse. Staff document these selections on a Participant Furnishing Receipt form. Participant is responsible for delivery of furnishings to their new address. The excess fair market value of furnishings provided over the amount paid by the partnering agency and/or the participant is recorded as support to individuals. In 2020 we added 2 additional funding support options for program participants; furniture match voucher and a moving voucher. These are monitored by staff and recorded on the furnishing receipt. The beds for children program provides beds and bedding at no charge. The case manager of the referring partner agency must make a home visit to confirm that the child/ren in the home need a bed.
