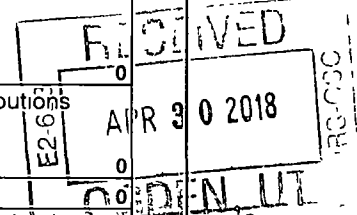



The purpose of the organization is to collect used furniture and other household items and redistribute these items to people who age-out of foster care in Summit County, Ohio. Each recipient is identified by a social worker at Summit County Children's Services. When the foster child reaches age 18 and becomes a candidate for self sufficiency, the social worker helps them find an apartment and a job. The social worker fills out a form with the foster child to identify the furniture and household goods needs and sends the form to Chair-ity. Chair-ity then confirms receipt, contacts the aged out foster child, reviews the needs of that child and schedules a delivery and furnishes the apartment with used furniture, a new bed, and other household goods as available.

Part II, Question 24. Other assets include used furniture that was donated by various individuals or organizations. Donated items include sofas, end tables, cocktail tables, lamps, dressers, rugs, pictures and various household goods. Other items could include new bed frames, new mattresses and new box springs as used mattresses and box springs are not distributed to recipients of Chair-ity furnishings.
