THE INN BETWEEN'S MISSION IS TO OFFER A SAFE AND COMFORTABLE PLACE WHERE UTAH'S TERMINALLY ILL HOMELESS MEN AND WOMEN CAN EXPERIENCE THE END-OF-LIFE WITH DIGNITY, RECEIVE PROFESSIONAL HOSPICE SERVICES AND BE SURROUNDED BY PEOPLE WHO CARE. WE ENVISION A COMMUNITY WHERE EVERYONE HAS ACCESS TO THE IN-HOME SERVICE OF HOSPICE CARE AND WHERE NO ONE DIES ALONE ON THE STREET.
