IN EARLY MARCH, FOLLOWING CDC AND UTAH DEPARTMENT OF HEALTH RECOMMENDATIONS, WE ENFORCED A STRICT LOCKDOWN, REQUIRED NON-FRONTLINE STAFF TO WORK FROM HOME, AND IMPLEMENTED SIGNIFICANT SHIFTS IN PROCESSES TO PROTECT OUR RESIDENTS.
