This will be a home like environment in our community with 24/7 wrap around holistic therapeutic services. A safe place for healing, growth, and preparing for integrating back into a safe home environment with healthy coping skills. Each home will be able to house up to 6 girls at a time, for at least a year in order to give them time to heal from the complex trauma they have experienced due to the trafficking. This restoration home will bring much needed specific care, hope, healing and restoration to these young girls.
