Food for Hope responded to the Covid-19 pandemic by expanding infrastructure and distributing triple the amount of food each week. Food for Hope served the Westminster Public Schools, Adams 12 Five Star, and 271 school districts with 23,440 bags from March - July

Food for Hope supplements the food available to elementary and high school students during the school day through our School Fuel program. Through this program, we distribute 3,200 high protein snacks per week to two high schools and five elementary schools in Adams County. These snacks assist students who would not otherwise have access to adequate food during the day receive much needed energy to engage more effectively in the classroom.

Food for Hope currently provides bags of nutritious food each week to 530 students at 10 schools in two Adams County school districts. These bags provide nutrition for the hunger gap that exists on the weekend when children are not receiving free/reduced lunches from school. Each elementary food bag includes a minimum of 2 protein items, 1 vegetable, 1 fruit, 1 grain, and 2 breakfast items. The cost of each bag is approximately \$3.00. Food for Hope distributed 11,765 of these bags in the previous year.
