 Our purpose is to provide feminine hygiene products to homeless, low-income, and at-risk people in the mid-Michigan area. We provide tampons, pads, pantyliners, wipes, bladder control products, and menstrual health workshops to 125 charity partners in Ingham, Eaton, Clinton, and Shiawassee counties. These partners include homeless shelters, food banks, after school programs, and 36 junior and senior high schools.
