<p><b>28</b> Currently, HopeAustin provides weekend meals for 650 plus students each week at 27 local schools across 3 districts. Each meal kit contains 2 breakfasts, 2 lunches, 2 dinners, 2 snacks as well as vital shelf stable protein drinks to ensure proper nutrition and calories. In addition, we operate food pantries at several middle/high schools. Food pantries provide for autonomy of choice which is something many of our students do not experience on a regular basis. Our meal programs ensure that local students are food secure, increasing the opportunity to meet physical and cognitive milestones, while also removing the number one barrier to a quality education - hunger. Further, our programs are proving to increase attendance among the student population we serve. To date, in this 2018-2019 school year, HopeAustin has served 17,469 meal kits with a projection to serve 19,000 meal kits by the end of the school year.
