**Part III -Organization's primary exempt purpose: Tutoring services in Math, Reading, and Language Arts for low and very low income student grades K-12th. Basic Learning Skills Learning Center provides no frills, real tutoring program. Students are taught by subject-area-certified tutors in Math and Reading. Each participant receives a total of 25 hours, of which 20 are institutional with the remaining 5 earmarked for parent/guardian consultation, pre- and post-test administration and evaluation. Parent/guardian conferences cover student progress and discussion of practical follow-up educational support activities that can be conducted in the home with children in between tutoring sessions. Curriculum and methodology remain essentially the same whether in home, individual tutoring or group setting at community facilities or or group homes. Tutoring sessions range from 1 to 1.5 hours. The tutors have the status of independent contractors. Snacks, refreshments, workbooks and other materials are provided to all participating children. The central goal is to assist participating students in attaining required levels of proficiency in Reading/Language Arts and Math through a targeted program of tutoring, addressing, , remediating specific specific skill areas. Each participating student is administered the Achieve assessment, a nationally normed criterion assessment to identify specific deficiencies in Reading and Math. An individualized learning plan follows, prioritizing the areas in which the student scored the lowest. At the end of the tutoring experience, a post-test is administered, as the principal method for determining student achievement. This This goal-oriented learning plan is also based on input from parents as well as the student's participating school where available, to assist in the development of the student's learning plan. Program success/outcomes are measured primarily from the standpoint of goal attainment as articulated in the student's individual learning plan.**
