ARC of West Central Colorado(ARCWCCO) provides advocacy to people with intellectual and developmental disabilities(IDD), ages birth to death. ARCWCCO provides free advice, consultative meetings,protecting the rights and access to services for people with IDD. ARCWCCO offers comprehensive advocacy within school systems, government, insurance and other community systems and agencies. In 2019, the client Advocacy caseload totalled 43 K-12 direct contact clients involving a minimum advocacy of participating in client IEP meetings. For adults, there were 19 direct contact clients. We anticipate caseloads continuing to rise over the next 3-5 years, but are hopeful that education and community/agencies will help people with IDD self-advocate toward total independence as an ultimate goal.
