 Emergency Veteran Services - Since we do not have housing on site yet, we have allocated part of our funding and often do "fire mission" fundraising drives to directly help veterans stay in housing or with emergency expenses to prevent them from becoming homeless  
*One example of direct Facebook drive was an elderly veteran that was on the verge of being evicted if he didn't make repairs to his trailer home*  
*Through donations of cash, gift certificates, and in kind donations we rallied the community (2 other veteran organizations, businesses, and civilian groups) to make the repairs and keep him in his home Other expenses to this program include homeless veterans needs (food, clothing, hotels on cold nights) and expenses to help struggling veterans such as utility bills, tires, school clothes/supplies for their children*  
*Another element to this program is accepting kind donations of furniture and household goods that we store temporarily until we find a veteran in need*  
*In 2018, 19 veterans were assisted by this program*

 Farming - As participants in the Texas Agribility BattleGround to Breaking Ground Program we were required to perform 100+ hours of hands experience on a working farm We found aquaculture farmers/mentors in Devine Texas From September 1, 2018 - March 31, 2019 we had volunteers perform daily feeding and maintenance of fish tanks We hosted several work days to make repairs to the hoop houses  
 Several of the volunteers were active duty airmen in leadership development classes at Lackland AFB  
 Other volunteers were veterans, spouses and families of active duty and veterans and a handful of civilians  
 In 2018 we had a total of 548 volunteer hours logged by

As a requirement of the program, we had to acquire a mentor with a working farm to get 100+ hours of hand on training We signed a mentorship agreement with Scott Farms in Devine, Texas As part of the agreement, we assumed the daily feeding/maintenance of the aquaponics farm We logged 548 hours with 37 volunteers between Sept 1-Dec 31, 2018 Also see Form 990 Part III 4b for more details

We continued all other programs from 2017 Emergency Veteran Services and Mental Wellness & Suicide Prevention were the other top 3 programs in regard to expenses and case logs
