 They donated the use of heavy equipment (track hoe/skid steers) for us to use cleaning the ReGroup Ranch in New Braunfels
 as well as an opportunity to teach veterans to operate the equipment via hands on training
 We had 7 veterans participate over 6 weekends completing approximately 420 hours of training
 1 veteran has now purchased and is running a business with his training

 utilities to prevent shut offs, clothing, car repairs and food These funds are generally raised via a FB fundraiser directly for veteran in need
 Our client load is at 88 veterans and 16 of them have received funding from this program
 Payments are always made directly to the landlord/hotel or utility company, or product/service if provided
