 MEANS Database modernizes food recovery by connecting excess food to organizations and individuals who need it. Since our founding, we have recovered over 2 million pounds of food that would have otherwise been thrown out and redirected the food to our nonprofit partners throughout the country. We built new partnerships with both food donors and nonprofits throughout the year and are now present in 49 states and the District of Columbia.
