Our mission is to help women and families who are homeless achieve self-sufficiency. We are a short-term shelter providing long-term solutions. Our immediate goal is to provide shelter and met the emergency needs of the clients. We provide safe and secure temporary emergency housing, case management that includes a needs assessment, formation of personal service plans, budgets and resumes, and assistance securing financial security, affordable housing, and meet individual basic human needs of clients at enrollment, during enrollment and upon exiting the program. OPI connects clients with mainstream, community, faith-based, and public resources and services. Our long-term goal is to help these individuals exit the shelter with improved financial security through increased benefits, income and/or earnings and access to permanent affordable housing.

Between July 1, 2016 and June 30, 2017, Opportunity Place sheltered 210 individuals (95 adults; 115 children; 16 single women, 58 families -- of which 38 were single-parent households; and 5 Veterans). The total # of sheltered nights was greater than 9,993. Shelter services included: temperature-controlled private rooms with beds and linens; showers and laundry facilities; bathroom facilities, non-commercial kitchen, play area, daily meals and snacks, computer labs for job / housing searches and connection to community resources and intensive case management and support services.

In addition to providing a roof over their heads in a secure environment, the following services/items were provided to all clients: 24,982 nutritious meals, basic care/personal hygiene products, linens and clothing. While families were enrolled at the shelter, 69 children were enrolled in early learning and childcare programs; 11-Head Start/Healthy Start/WIC; and 22 school aged children (not previously enrolled) were enrolled in school. All adults had access to budgeting, resume and job searching skills training and were connected to Career Source. Fifty (50) clients received mental/emotional/physical health care and Rx, and all received assistance obtaining sustainable employment and affordable housing. More than 79% completed the program with improved financial security and/or permanent housing.

Total in-kind contributions for Fiscal Year 2016-17 totaled \$79,073.68. The facilities and grounds used to provide temporary emergency shelter and services were donated by Community Development Corporation at a value of \$72,600.00 annually and donated maintenance goods and supplies was estimated at \$1,750.00 Destin Harvest provide 43,779 pounds of food foruse at the shelter and for community distribution. Volunteers donated 582 hours with an estimated value of \$4,683.00
