Part III, Line 4a SHELTER SERVICES AND OPERATIONS - Opportunity Place, Inc. (OPI) is a temporary emergency shelter for families and single women experiencing homelessness and who are predominately from Okaloosa, Walton and neighboring counties. Our mission is to help families and single women who are homeless achieve self-sufficiency. We are a short-term shelter providing long-term solutions. Our immediate goal is to provide shelter and meet the emergency needs of the clients. We provide safe and secure temporary emergency housing case management that includes a needs assessment, formation of personal service plans, budgets and resumes and assistance achieving financial security security and affordable housing. OPI meets the individual basic human needs of clients at enrollment, while sheltered and upon exiting the program. OPI connects clients with mainstream, community, faith-based and public resources and services. Our long term goal is to help these individuals exit the shelter with improved financial security through increased benefits, income and/or earnings and access to permanent affordable housing.

Between July 1, 2017 and June 30, 2018, Opportunity Place sheltered 207 individuals (91 adults; 116 children; 27-single women; 56)-families of which 41 were single-parent households; and 5 Veterans). The total number of nights individuals were shelter (and not on the streets) was 10,240 nights. Shelter services included: temperature-controlled private family rooms with beds and linens, showers and laundry facilities, non-commercial kitchen, play area, daily meals and snacks, computer lab for job and housing searches, and connections to community resources and intensive case management and support services.

In addition to providing a roof over their heads in a secure environment, the following services/items were provided to all clients: 15,360 nutritious meals, basic care/hygiene products, linens and clothing. While families were at the shelter 65 children were enrolled in early learning and childcare programs. 24 school-aged children were enrolled in school. All adults had access to budgeting, financial management, resume and job-seeking skills training and were connect to Career Source. 129 clients received behavioral/mental/physical health care and Rx and all received assistance obtaining sustainable employment and affordable housing. More than 73 completed the program with improved financial and housing stability.

Tin-kind contributions for fiscal year 2017-18 totaled \$225,407.49. The use of the facilities and grounds used to provide temporary emergency shelter was donated (in-kind) by the Okaloosa Community Development Corporation at a value of \$74,300.00. Destin Harvest provided over 55,500 pounds of food for use at the shelter and for distrution through OPI's community food distribution program. Individuals and groups provide 1,318 volunteer hours with an estimated value of \$22,843.00.
