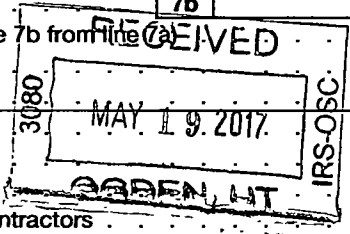

Part III Statement of Program Service Accomplishments: Each allocated expense is 25% of employee labor, utilities, and advertising.

28. Providing Public Charity: The Market operates the Welcome Center in partnership with Paris-Bourbon County Tourism. This relieves a significant managerial burden from City and County government and provides a beneficial service to the community. The Market coordinates the distribution of produce through God's Pantry and participates in three USDA programs: WIC, Seniors, and SNAP. In 2016 the KY Ag. Development grant was used to renovate the meeting space, upgrade two bathrooms, and install small kitchen. This space is now called the "City Barn" and is rented out to the community for a nominal fee. This much needed service has been well- received by the community.

29. Promoting Economic Development: The Market supports local farmers and artisans by providing an outlet for their products. Vendors can set up and sell outside or leave their products to be sold inside the Market. Over 60 vendors participate every month.

The Market promotes tourism in the community by providing space and manpower to operate the Welcome Center. Located downtown, with plenty of parking, visitors find the Welcome Center to be both accessible and convenient by being open five and a half days a week.

30. Providing Educational Opportunities: The Market partners with the local Extension office to educate both consumers and vendors on nutrition and production related topics. The Market partnered with the local Health Dept by sponsoring a "Healthy Kids" Saturday event.
