The teens reaching adult independent living (TRAIL) program assists young people navigate what would otherwise be a very complicated path from adolescence to adulthood for children preparing to age out of the foster care system. During this period on average 37 youth were served each month by the PRTF and 10 youth were served each month by TRAIL.
