Turner House Children's Clinic provides high quality pediatric health care services to Kansas City's underserved and uninsured children, ages 0-19. Located in the heart of a low-income, Hispanic, working class neighborhood in Kansas City, Kansas, Turner House serves an ethnically and racially diverse population with culturally competent, bilingual care. More than 73% of patient families live at or below the federal poverty level, 100% of patient families live below 200% of the federal poverty level. Turner House has been nationally recognized by the National Committee on Quality Assurance (NCQA) as a Patient-Centered Medical Home (PCMH), a practice model which emphasizes care coordination and communication with patient families, providers and care teams to ensure that patient needs are met. Because Turner House providers get to know patients and their families, they are better able to ensure that children receive age-specific developmental physicals and immunizations, that chronic conditions are managed, and that life-threatening illnesses and diseases requiring specialty care are diagnosed. Because of Turner House, children who otherwise might only be seen by a doctor in a hospital emergency room, have a pediatric medical home - a place where they can receive the best preventive health care and an improved chance at a healthy life. During 2015, Turner House served 5,401 patients in 12,591 visits. Volunteers included pediatricians and community volunteers who provided a total of 298 volunteer hours.

Dental canes (cavities) are rampant in Turner House patients, many of whom have received no preventative oral hygiene care. As a result, Turner House provides a portable dental hygiene program to area schools and in-clinic. This program includes dental screenings, teeth cleaning and scaling, and the application of fluoride varnishes and dental sealants.
