Community building and civic engagement training to ensure that everyone has the opportunity to thrive in our communities. ONE Northside organizes people and institutions in Rogers Park, Edgewater, Uptown, Ravenswood, Lake View, North Center and Lincoln Park around social justice issues that impact them locally and at a larger scale. ONE Northside's membership is made up of 91 institutions and over 900 individuals. ONE Northside also trains over 500 people annually in community organizing and civic engagement. ONE Northside's issue platform includes economic justice, police accountability, mental health justice, education and affordable housing.

Training parent leaders and working in local schools to address education issues. ONE Northside started a parent mentor program in Greeley Elementary School, which put parents in the classroom to help teachers and improve their own skills. ONE Northside is also educating and engaging parents in organizing efforts for equitable education funding.

Organizing people and institutions to ensure the preservation of affordable housing in the community and creation of new affordable housing for all size households. ONE Northside has educated and organized tenants in at risk affordable building so they can work for preservation and improvement of their buildings, including tenants from the Wilson Men's Hotel, the Darlington and the Lorali. ONE Northside has organized residents to push for more affordable units in new developments and the adoption of rent control in Illinois.
