Phase two of the grant program, which provides grants to existing homeowners in mortgage distress in targeted communities hardest hit by the foreclosure crisis, was launched in the 1st quarter of 2016. Eight (8) grants were provided to distressed homeowners in seven (7) targeted communities in 2018, for a total of \$90,956.39, allowing the grant recipients to avoid losing their home to foreclosure.
