Grocery Outlet, a local cannery, who can a variety of vegetables grown in the northwest.

Farmers bring in produce from their farms, these may include, corn on the cob, apples, pears, plums, blueberries, tomatoes and many other vegetables, too many for their own use.

Food drives are carried out by local groups, like the police, firemen, schools, churches, boy scouts and others. Fresh fruits and vegetables are given out the week received, unless they will stay fresh for days. We have coolers when that is necessary to keep produced received.

Part VII line g \$331,770 is the value of food provided to the food bank by a variety of sources. Pounds received is then calculated by using \$1.50 as the value per pound. Part XI does not seem to take into consideration this amount is not actual cash dollars.

Example. If we receive 400 pounds of tomatoes, the value is \$600, but not cash. Food distribution centers regularly require the value of food supplied.

Part IX line 24d food distributed to clients is also valued at the same \$1.50 per pound.
