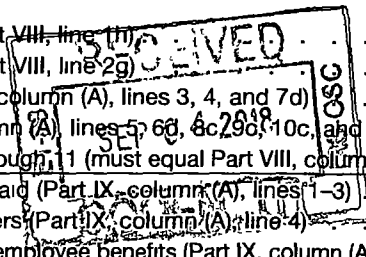

Part V111 line f. \$59,626 is the actual cash income from all sources, this amount is used to pay all expenses for the operation of the food bank. This includes office expenses, the internet/computer, insurance, taxes, phone and security access, water, refuse, lift truck and other equipment used in the warehouse and purchase of food staples not received as in-kind items.

Part V111, line g. \$455,514 the value of food supplied to the food bank from a number of sources. Example, community members, local grocery stores, food drives from schools, police and fire departments, postal workers, United Way, Lewis County Coalition, Northwest Harvest, Food Bank and others.

Part X11 line 3 a A copy of all income and expenses is supplied to each board member at the regular meeting, held on the second Tuesday of each month. A copy of the Security Bank statement and reconciliation is given to the board president and vice president for review and approval. Every three years the books are subject to an audit.
