 Food shelf and related programs include client access to professional social workers, who provide crisis counseling, support, advocacy, and referrals. The food shelf provides food and personal items, distributing 577,054 pounds over 7,022 household visits. Related projects also include providing required school supplies to students. STEP provided personalized school supplies to 454 children and backpacks to 307 children. Food and grocery certificates specific to holidays to eligible families enable them to fully participate in holiday traditions. STEP's holiday toy drive supplied gifts or gift certificates to families of 601 children at an average of \$30 per child.

**4b** (Code ) (Expenses \$ 304,794 including grants of \$ 239,408 ) (Revenue \$ )  
 Clothes Closet provided no-cost, gently-used clothing and household items to 6,150 eligible families and individuals. STEP distributed 8,054 bags of clothing and 1,104 coats during this fiscal year.

**4c** (Code ) (Expenses \$ 46,279 including grants of \$ 27,602 ) (Revenue \$ )  
 Emergency financial assistance is provided for eligible housing and other essential life expenses. The primary goal of the program is to prevent homelessness. During this fiscal year, \$27,002 was distributed to 35 households for rent.
