4a (Code) (Expenses \$ 34,017,209 including grants of \$ 30,362,500) (Revenue \$)

Across our 5-county service area, The Emergency Food Assistance Program (TEFAP) distributed 407,046 food boxes to 198,604 people experiencing hunger in partnership with USDA, the Arizona Department of Economic Security and 69 nonprofit and faith-based community partners. Food boxes were provided at our main warehouse in Tucson, at our four branch locations in Amado, Marana, Green Valley and Nogales, and at over 30 rural distribution sites in the three southeastern Arizona counties (Cochise, Graham and Greenlee). Boxes include non-penshables such as canned fruit and vegetables, peanut butter, soup, cereal, rice and beans, and are supplemented with fresh produce and other goods procured through our network.

4b (Code) (Expenses \$ 24,650,200 including grants of \$ 23,295,084) (Revenue \$)

The Agency Market & Partnership Program provides hunger relief to individuals and families who seek services from organizations other than the Community Food Bank of Southern Arizona. Many reside in homeless, domestic violence shelters or transitional housing communities. Fresh produce, meats, milk, cheese and eggs are rescued from local grocery retailers and distributed through a partner network of 230 nonprofit and faith-based organizations who provided nearly seven million pounds of food across both urban and rural areas of Southern Arizona. To better serve the 29,000 food-insecure individuals across 20 rural communities in Cochise, Graham and Greenlee counties, the Willcox Distribution Center was opened in September 2015.

4c (Code) (Expenses \$ 4,256,061 including grants of \$ 3,679,403) (Revenue \$)

In partnership with USDA and the Arizona Department of Health Services, the Commodity Supplemental Food Program (CSFP or Food Plus) improved the health of an estimated 8,000 low-income seniors by providing approximately 5,500 supplemental emergency food boxes each month that deliver nutrients typically lacking in that population. Food boxes were provided at our main warehouse in Tucson, and our four branch locations in Amado, Marana, Green Valley and Nogales. Boxes include non-penshables such as canned fruit and vegetables, shelf-stable milk, soup, cereal, rice and beans, as well as perishable items including juice, fresh milk and cheese. Boxes are supplemented with fresh produce procured through our Nogales facility.

The Community Food Resource Center oversees all education, advocacy and community development activities aimed to empower individuals to become economically self-sufficient and strengthen community health and economic vitality. The Center served an estimated 16,000 people and promoted economic and community development through the following activities and accomplishments. Farm to Child program provided training to over 35 public school teachers in numerous area school districts on school garden programs. In addition, FTC trained over 100 college student interns to assist with school garden programs and assisted over 10 schools in garden startup. Managed three farmers' markets that provided more than 800,000 servings of locally grown fresh fruits and vegetables in "food deserts" in Pima County, generating \$341,000 in sales for local growers. During the current year we had two main grant initiatives. The Punch Woods Endowment Grants are limited to supporting Community Food Security programs. A panel of food bank staff and community leaders review applications from eligible 501(c)(3) organizations. Depending on the number of applicants and fund requested, any number of applications may be funded until the funds are depleted. This is an annual process and all awardees are chosen and paid at one time. In addition to the Punch Woods grants, we also award agency capacity building grants. Agency capacity building grants are awarded agencies who have or will partner with the food bank or who's impact on the community compliments the food bank's mission. These awards are designed to improve an organization's long-term ability to serve its constituency, increase the quality of its programs or meet compliance standards allowing continued service as a food bank partner. The applications for these grants are reviewed by staff members and awarded as needed throughout the year. Depending on the use of the funding, staff will either observe the outputs in person or receive evaluative reports from the grantees in order to monitor the use of the funds.
