The Foundation maintains an endowment fund for the exclusive benefit of the YMCA of Middle Tennessee. Earnings on the endowment are used for programs and services of the YMCA. During 2018, the Foundation made grants to the YMCA totaling \$365,765.

In addition to the endowment fund, the Foundation also maintains a few small philanthropic funds. Similar to donor advised funds, principal and earnings on these funds are used to support the charitable interests of the individuals who established them. During 2018, these funds were used to support 4 charitable organizations around middle Tennessee in the amount of \$29,729.
