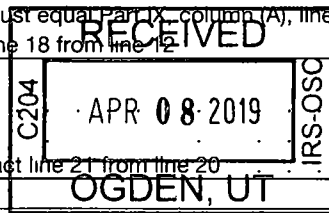

The ESG program funds are intended to target two populations of persons facing housing instability: (1) individuals and families who are experiencing homelessness (residing in emergency or transitional shelters or on the street) and need temporary assistance in order to obtain housing and retain it, and (2) individuals and families who are currently in housing but are at risk of becoming homeless and need temporary rent and utility assistance to prevent them from becoming homeless or assistance to move to another unit.

4b (Code:) (Expenses \$ 213,039 including grants of \$ 0) (Revenue \$ 180,546)

Challenge Grant are to enable persons assisted under this grant program who are homeless to return to permanent housing thereby ending their episode of homeless or to provide assistance or programs consistent with local continuum of care plans that address the needs of the homeless in the community.

4c (Code:) (Expenses \$ 51,998 including grants of \$ 0) (Revenue \$ 65,895)

PERMANENT SUPPORTIVE HOUSING (PSH)- This program was designed to help chronically homeless persons who are identified as either:

- 1 An unaccompanied homeless individual with a disability condition who has been continually homeless for a year or more or
 - 2 An unaccompanied individual with a disabling condition who has had at least four (4) episodes of homelessness in the past three (3) years
- Individuals or families served by the Permanent Supportive Housing for chronically homeless individuals will be housed due to chronic homelessness. Accomplishments Based on the agreement that exists between Department for Children and Families (DCF) and, and the grant management agency, Heartland Coalition for the Homeless (HCH) for the reporting period November 2017 - October 2018, activities should be fourteen (14) households with the head of household having a disability. The PSH Grant total is \$119,000 for rental assistance, case manager assistance, and administration assistance.
