BUSINESS DEVELOPMENT - Through its monthly business orientation sessions, LEDC provided information to entrepreneurs on the basics of starting a business feasibility steps, how LEDC can assist in the process, and the benefits of becoming a member of LEDC. Through LEDC micro-entrepreneur trainings, there is a session that provides information on how to prepare for a business loan either through LEDC, a traditional lender (i.e. a bank), or a non-traditional lender (i.e. another community development non-profit organization). Over 475 hours of technical assistance were provided to start-up and existing businesses. LEDC continued providing services to small businesses in rural communities and continued to promote agricultural cooperative business development among immigrant vegetable growers, providing services to both individual Latino farmers, farmers in cooperatives, and prospective farmers. LEDC reached over 50 individuals interested in farming. LEDC also worked to support a multicultural agricultural marketing cooperative which included Latino and non-Latino farmers working together to pool resources and land accounts they could not achieve on their own. LEDC expanded its reach into Southern Minnesota, with clients as far away as New Ulm and Rochester, opening its new office in Austin. LEDC provided technical assistance to 5 businesses and 3 start-ups and started processing 4 loans. Thanks to our work developing rural areas, LEDC was invited to present as part of the White House Rural Council.

Form 990, Part III, Line 4b:

EDUCATION AND TRAINING - Latino Academy TTOIC, a workforce training program of LEDC, empowers individuals by combining adult basic education and job readiness. The work areas of the curriculum are business training, workforce development, GED preparation, and certifications. The Latino Academy TTOIC served 353 clients, helped 49 job seekers find a new job, educated 40 full time GED students, and had its first three GED graduates, with more in process ledc, through its latino scholarship fund, awarded eleven scholarships in 2016.

LENDING PROGRAMS - Thirteen loans were packaged and approved, totaling \$300,000, funds for these loans came from LEDC's loan pool, nine loans were repaid, totaling \$55,000, an additional amount was leveraged with these funds from local banks and community lenders. LEDC continued a program in partnership with Mission Asset Fund of California called "Lending Circles." Lending Circles are zero-fee, zero-interest credit-building social loans. Borrowers become lenders and lenders become borrowers, a collective monthly savings became a loan for a participant. Every month the savings are reported as a loan payment to the credit bureau.
