Ag Development: LEDC continued to promote agricultural farm business development among immigrant vegetable growers and livestock small producers, providing services to individual Latino farmers, farmers in cooperatives, and prospective farmers. Over 1,500 hours of technical assistance were provided to 26 farmers and 5 stockmen. LEDC also worked to support a multi-cultural agricultural marketing cooperative which included (7) Latino and (1) non-Latino farmers working together to pool resources and land accounts they could not achieve on their own. LEDC was a key player in creating a link between Latino blueberry growers in Michigan with a Latino-owned farmers' cooperative in Minnesota. This led to \$85,000 of blueberry sales for Michigan farmers in Minnesota markets. LEDC played a key sponsorship and advisory role in the Emerging Farmers Conference, the nation's premiere farmer's conference geared towards BIPOC and Immigrant farmers. More than 200 farmers attended the Conference over two days. LEDC processed loans for eight farmers and continued to create close relationships with Minnesota's Rural Finance Authority and Farm Service Agency.

Business Development: Through its monthly business orientation sessions, LEDC provided information to entrepreneurs on the basics of starting a business feasibility steps, how LEDC can assist in the process, and the benefits of becoming a member of LEDC. Through LEDC micro-entrepreneur trainings, there is a session that provides information on how to prepare for a business loan either through LEDC, a traditional lender (i.e. a bank), or a non-traditional lender (i.e. another community development non-profit organization). Over 1,000 hours of technical assistance were provided to start-up and existing businesses in twin cities area and more than 200 hours in greater Minnesota. LEDC provides a wide range of services for new and expanding businesses through one-on-one coaching. Areas of coaching include business planning, financial matters, cash flow needs, financial statements interpretation and marketing. Technical assistance is offered to clients when they are ready to start the process of becoming business owners.

Form 990, Part III, Line 4b:

Education and Training: In 2019, 94 people participated in 41 micro-entrepreneurship training sessions, totaling 82 hours of training and 3,952 hours of accumulated individual training. Aspiring entrepreneurs received additional support from our business development team, which consisted in 260 hours of technical assistance, 195 hours of assessment support, and 233 hours of follow up through outreach. In total, our clients received 4,640 hours of business development support. Our academy also provided GED and English classes. Outcomes for these programs are as follows: We served 31 students in our GED program. We provided 96 sessions, totaling 768 hours of group training, and 11,904 hours of cumulative training. Lastly, we served 5 students in our ESL program. We provided 20 training sessions, totaling 40 hours of group training and 200 hours of cumulative training.

Lending Programs: For 2019, 14 loan packages were approved and closed, totaling \$659,791.00 disbursed by LEDC. The funds for these loans came from LEDC's loan pool. Fifteen loans were paid in full. Through partnerships, additional funds were leveraged from state programs, local banks and community lenders. Over 90K came from DEED/ELP as matching funds. 27 thousand disbursed by RFA in loans for farmers. Over 2 million dollar leveraged. 2019 CDFI Certified Lender. From its creation until 12/31/19, LEDC has disbursed over 5 million dollars to support Latino owned businesses.
