Ag Development: In 2020 the LEDC Agricultural Program led the way for Latino agricultural entrepreneurs in the Twin Cities and across greater Minnesota. LEDC continued to be a complete one-stop agricultural business program for all of our clients, providing technical assistance, business development, access to capital and markets, as well as specialize in Organic and food safety certifications. In 2020, LEDC worked closely with Shared Ground Farmers' Cooperative to sell over \$140,000 of Latino grown vegetables. We registered 1 new Latino farm enterprise and provided 3 Latino farm loans for a total of \$65,000. Working with partners in Michigan, we helped bring \$20,000 of Latino grown blueberries into the Twin Cities marketplace. LEDC began a partnership with The Good Acre, Hmong American Partnership, Lakewind's Coop, and Mill City Farmers' Market to create the LEAFF Program (Local Emergency Assistance Farmer Fund). The fund raised over \$400,000 to distribute to BIPOC farmers. The program bought produce from local BIPOC farmers and then distributed all of the product for free to communities in need. The program registered 47 farmers into the program. Each farmer was able to bring up to \$7,500 of any produce they have. Produce was distributed for free to over 15 sites around St. Paul and Minneapolis. LEDC Ag team did over 1,200 hours of technical assistance to 53 farms in Minnesota and Western Wisconsin. In 2020, MDA staff contacted the Latino Economic Development Center (LEDC) to help disperse \$340,000 in CARES ACT funding to BIPOC Agricultural Producers and Workers in Minnesota. The split was \$210,000 to Agricultural Producers for grants of up to \$5,000 and \$130,000 to Agricultural Workers for grants of \$1,000.

Business Development: 2020 was a unique and challenging year due to Covid-19 pandemic and social unrest in the Twin Cities during the summer. Restaurants, beauty salons, barber shops, fitness centers and other service providers felt the impact of these events. The Business Development team made an extraordinary effort to assist businesses throughout the state with grants and low interest loans from several programs such as DEED Small Business Emergency Loan, Small Business Relief Grant, Cultural Malls, SBA PPP, Ramsey and Hennepin counties grant programs, Twin Cities United Way grant program, etc. We were able to invest more than 2,500 hours collecting, examining, processing applications and documentation to approve, disburse grants and loans to more than 500 businesses, totaling \$5,000,000. Additionally, we provided more 1,100 hours of technical assistance to start-ups, worked and guided business owners to apply for different grant opportunities. The Business Development team also assisted more than 100 businesses with small grants, ranging from \$1,000 - \$5,000 on the Lake Street corridor and St. Paul.

Form 990, Part III, Line 4b:

Education and Training: In 2020, our team grew from 7 to 48 members. We had 295 participants enrolled in GED, ESL, micro-entrepreneurship training and business coaching sessions; and held 42 training business sessions totaling 84 hours of service or 10,164 hours of accumulated individual training. Furthermore, we trained participants on Science, Math, and Reasoning Through Language Arts portions of the GED test. This service consisted of 54 weeks with over 1,000 hours of instruction and follow up. In connection with employment services, we served 11 participants and assisted them with filing unemployment benefits and or employment search and placement. Our team delivered housing assistance to Minnesotans affected by the economic downturn resulting from the public health emergency, Covid-19. We approved and paid 2,772 housing assistance requests to 1,206 Minnesotan households in 60 counties. The total value of housing assistance delivered was: \$4,712,550. Lastly, during the height of the Covid-19 pandemic, we proudly delivered over 5,000 lbs. of fresh produce to Latino families afflicted by unemployment and lack of governmental resources.

Form 990, Part III, Line 4c:

Lending Programs: In 2020, 57 loan applications have been approved, 53 loans were closed, 4 loan modifications, and 5 loans were paid in full. The total amount disbursed by LEDC was over 1.4 million dollars. With the approval of the 57 loans, LEDC contributed to retain 214 full/time jobs and 181 part/time jobs. Of the 53 loans closed in 2020, 49 loans totaling \$1,320,000 were Small Business Emergency Loans (SBEL) closed in the three-month period between late April and mid-July. This special program was the response from Minnesota Department of Employment and Economic Development (DEED) to the Governor's executive orders in March shutting down restaurants, salons, fitness centers and other businesses. LEDC added 2 new sources of funds to the program (Women Foundation \$150K and Bremer Bank \$200K). In 2020, LEDC was recertified by the U.S. Treasury Department as a Community Development Financial Institution (CDFI). LEDC continues to as a certified lender under DEED's Emerging Entrepreneur Loan Program (ELP).
