With comprehensive and evidence based services, addressing both emergency and long-term needs, we help women achieve personal stability and make meaningful gains in their housing, income, employment, mental health, physical health and addiction recovery status. In the past year, we welcomed nearly 2,000 homeless and low-income women across five locations. Of those 2,000, more than 700 women and 51 families were provided supportive housing. Additionally, we tripled the number of meals we served compared to last year, totaling more than 200,000. Most of the women we served were African American, over 50 years old, and had no income when they came to N Street Village for the first time. Sixty-four percent had a disability, including physical, mental, developmental, addiction or a combination thereof. Six percent self-reported being HIV positive.
