NLIHC is dedicated solely to achieving socially just public policy that ensures people with the lowest incomes in the United States have affordable and decent homes. NLIHC conducts research on affordable housing in the U.S. and educates, organizes and advocates for decent, affordable housing, especially for those most in need. NLIHC's goals are to preserve existing federally assisted homes and housing resources, expand the supply of low income housing, and establish housing stability as the primary purpose of federal low income housing policy. NLIHC's recent accomplishments include - Produced and distributed a flagship online and print research product, Out of Reach, which documents the "Housing Wage" needed for a household to afford a modest rental apartment in every state and jurisdiction in the country and showcases the gap between prevailing rents and what renters earn and the minimum wage everywhere in the U.S. Out of Reach attracted extensive media coverage, including by The Wall Street Journal, The Washington Post, Forbes, The Chicago Tribune, Time Magazine, City Lab, Vox, Politico, NPR News, and many others. Part I, Line 2	<p>Hotel and travel assistance is provided for some low income individuals and some others (e.g., panelists, speakers) participating in our annual conference/forum. In most cases expenses are paid for directly by NLIHC, not by the individuals. In that regard, such expenses are tracked and accounted for in the same manner as all other expenses. In some cases, conference/forum participants purchase economy-fare airline or train tickets and are reimbursed by NLIHC. Modest stipends (\$800-\$1200) were provided to student interns volunteering at NLIHC offices during the fall, winter and summer school semesters. NLIHC provided a grant to the National Low Income Housing Policy Center (the Policy Center), which is a related organization that is exempt under 501(c)(4) to perform various lobbying activities in support of NLIHC's mission. All staff of the Policy Center must record any time incurred for lobbying in their electronic time sheets. Once all staff have entered their time for each month, the Chief Operating Officer (COO) then pulls a report that details any staff time charged to direct or grassroots lobbying and to the Annual Policy Forum (a percentage of which is charged to the Policy Center because the forum includes a lobby day on Capitol Hill) and calculates the Policy Center's salaries, taxes and benefits based on these time sheets. The COO also monitors all other expenses monthly and ensures any related to grassroots or direct lobbying are assigned to the Policy Center in the financial system.</p>
