From time to time, the fair value of assets associated with the donor-restricted endowment fund may fall below the level that the donor or the Act requires to be retained as a fund of perpetual duration. Deficiencies of this nature are reported in net assets with donor restrictions. LCE has interpreted the Act as permitting spending from an "underwater" fund, in accordance with the prudent measures required under the law. As of December 31, 2018, the original gift value of the donor-restricted endowment fund was \$301,704 and the fund had a deficiency of \$18,150.</p>
