HISTORICALLY, IN A HIGH PERCENTAGE OF THE CASES NVLSP HAS APPEALED, NVLSP HAS BEEN ABLE TO OBTAIN A REVERSAL OF THE BVA DENIAL AND AN ORDER TO GRANT BENEFITS OR (MUCH MORE OFTEN) AN ORDER SETTING THE BVA DENIAL ASIDE BASED ON ADMINISTRATIVE ERROR AND REMANDING FOR FURTHER ADMINISTRATIVE PROCEEDINGS.

IN 2020, NVLSP FORCED THE VA IN A PENDING CLASS ACTION TO PAY MILLIONS OF DOLLARS IN IN RETROACTIVE BENEFITS TO SURVIVORS OF DECEASED VIETNAM VETERANS WHO SUFFERED FROM DISEASES THAT WERE THE RESULT OF EXPOSURE TO AGENT ORANGE. IN ADDITION, NVLSP PREVAILED IN 2019-2020 ON FOUR OTHER CLASS ACTIONS. IN THE FIRST CASE, NVLSP REPRESENTED A CLASS OF THOUSANDS OF VA BENEFITS CLAIMANTS WHO FILED AN APPEAL TO VA'S HIGHEST TRIBUNAL, THE BOARD OF VETERANS' APPEALS (BOARD), AND SUFFERED EXTENDED DELAYS WAITING FOR VA TO TRANSFER THE APPEAL TO THE BOARD. IN ITS JUNE 13, 2009 DECISION, THE COURT HELD THAT VA'S DELAY IN MOVING THESE APPEALS FORWARD CONSTITUTED UNREASONABLE DELAY AND ORDERED VA TO FORWARD ALL CLASS MEMBERS' APPEALS TO THE BOARD FOR DECISION WITHIN 120 DAYS. IN THE SECOND CASE, NVLSP CHALLENGED THE 2018 VA REGULATION BARRING THE VA FROM REIMBURSING A VETERAN FOR THE EMERGENCY MEDICAL EXPENSES THEY INCURRED AT NON-VA FACILITIES THAT WERE NOT COVERED BY THE VETERAN'S PRIVATE INSURANCE. THE CAVC CERTIFIED A CLASS CONSISTING OF 75,000 VETERANS WHOSE CLAIMS FOR REIMBURSEMENT OF EMERGENCY MEDICAL EXPENSES WERE DENIED BY VA ON THE GROUND THAT THE VA REGULATION PROHIBITED THE AGENCY FROM REIMBURSING DEDUCTIBLE OR COINSURANCE PAYMENTS FOR WHICH THE VETERAN IS RESPONSIBLE. THE CAVC INVALIDATED THE PROHIBITION IN THE VA REGULATION ON THE GROUND THAT IT VIOLATED THE EMERGENCY CARE FAIRNESS ACT OF 2010 AND VOIDED ALL 75,000 DENIALS OF REIMBURSEMENT TO CLASS MEMBERS FOR MEDICAL EXPENSES DEEMED DEDUCTIBLES OR COINSURANCE MADE UNDER THE INVALIDATED REGULATION. THE CAVC ALSO ORDERED VA TO SEND MORE THAN 1,000,000 (ONE MILLION) INDIVIDUAL LETTERS TO CORRECT VA'S PRIOR ERRONEOUS DESCRIPTION OF THE STATUTORY REIMBURSEMENT CRITERIA THAT POTENTIALLY DISCOURAGED OTHER VETERANS FROM PURSUING THEIR REIMBURSEMENT CLAIMS AND GAVE THEM A NEW ONE-YEAR PERIOD WITHIN WHICH TO APPEAL ANY DENIAL OF REIMBURSEMENT. IN A THIRD CASE, A U.S. DISTRICT COURT CERTIFIED A PLAINTIFF CLASS OF MORE THAN 7,000 COMBAT VETERANS IN 2019 IN A LAWSUIT BROUGHT BY NVLSP CHALLENGING THE POLICY OF THE MILITARY DEPARTMENTS TO IMPOSE A CAP OF A MAXIMUM OF SIX YEARS OF RETROACTIVE COMPENSATION TO VETERANS WHO ARE AWARDED COMBAT RELATED SPECIAL COMPENSATION (CRSC). THE COURT EARLIER DENIED THE GOVERNMENT'S MOTION FOR JUDGMENT ON THE GROUND THAT PLAINTIFF WAS CORRECT IN ARGUING THAT THE SIX-YEAR STATUTE OF LIMITATIONS SET FORTH IN 31 U.S.C. 3702(B) DOES NOT APPLY TO CRSC. THIS CASE IS STILL ONGOING. FINALLY, IN 2020, NVLSP SUCCESSFULLY MOVED TO ENFORCE A 1991 CONSENT DECREE OBTAINED BY NVLSP ON BEHALF OF A CLASS OF HUNDREDS OF THOUSANDS OF VIETNAM VETERANS EXPOSED TO AGENT ORANGE AND THEIR SURVIVORS. THE MOTION CHALLENGED VA'S REFUSAL TO PAY RETROACTIVE COMPENSATION UNDER THE CONSENT DECREE TO NAVY VIETNAM VETERANS WHO SERVED OFF THE COAST OF VIETNAM. THE VA BASED ITS REFUSAL TO PAY ON THE GROUND THAT FORMER SAILORS WERE NOT ENTITLED TO THE PRESUMPTION OF AGENT ORANGE EXPOSURE BECAUSE THEY NEVER SET FOOT ON THE LAND MASS. THE DISTRICT COURT HELD THAT VA'S POSITION WAS UNLAWFUL AND ORDERED THE VA TO REVIEW THE CASES OF OVER 60,000 NAVY VIETNAM VETERANS TO DETERMINE WHETHER THEY WERE ENTITLED TO RETROACTIVE COMPENSATION BECAUSE THEY SERVED WITHIN 12 NAUTICAL MILES OF THE COAST OF VIETNAM.

THE PRINCIPAL FACTORS CONSIDERED BY THE ECC IN DETERMINING THE PRESIDENT'S COMPENSATION ARE: (A) THE EXPERIENCE OF THE PRESIDENT IN ADMINISTERING THE AFFAIRS OF NVLSP OR COMPARABLE ORGANIZATION; (B) THE EXPERTISE OF THE PRESIDENT IN VETERANS LAW; (C) THE RANGE OF COMPENSATION PAID TO SIMILARY QUALIFIED EXECUTIVES OF OTHER NON PROFIT ORGANIZATIONS OF SIMILAR SIZE AND BUDGET IN THE WASHINGTON, DC, GEOGRAPHIC REGION, AS DOCUMENTED BY PUBLISHED DATA SUCH AS THE LATEST SURVEY OF "ALL NON PROFIT ORGRANIZATIONS, DISTRICT OF COLUMBIA" BY ABBOTT LANGER ASSOCIATES; AND (D) THE QUALITY OF THE PRESIDENT'S JOB PERFORMANCE. THE ECC REVIEWS THE PRESIDENT'S COMPENSATION ANNUALLY (TYPICALLY IN DECEMBER) AND SETS HIS OR HER LEVEL OF COMPENSATION FOR THE COMING YEAR BASED ON THE FOREGOING CONSIDERATIONS. CONTEMPORANEOUS DOCUMENTATION MEMORIALIZING THE ECC'S DISCUSSIONS AND DECISIONS IS MAINTAINED. THE LAST COMPENSATION REVIEW TOOK PLACE DECEMBER 2020. THE PRESIDENT DETERMINES THE COMPENSATION FOR THE OTHER OFFICERS AND KEY EMPLOYEES BASED ON THEIR PERFORMANCE AND COMPARABLE SALARY DATA. THE PROCESS IS DOCUMENTED BY A MEMO TO THE PERSONNEL FILES.</p>
