THE PROCEEDINGS WHERE CONFLICTS OR THE APPEARANCE OF CONFLICTS WERE DISCUSSED, INCLUDING THE ACTIONS TAKEN, THE TERMS OF ANY MATTER APPROVED, THE NAMES OF THE DIRECTORS PRESENT AND HOW THEY VOTED, THE COMPARABILITY DATA RELIED ON BY THE BOARD, AND ANY ACTIONS TAKEN BY A PERSON HAVING A CONFLICT OF INTEREST ARE RECORDED IN THE BOARD MINUTES.
