PROGRAMS AND REGULAR MONITORING HELP RESIDENTS RETAKE CONTROL OF THEIR LIVES AND BECOME INDEPENDENT AND SELF SUFFICIENT. THC'S HOUSING WITH CARE PERMANENT SUPPORTIVE HOUSING (PSH) PROGRAM PROVIDES AFFORDABLE HOUSING WITH APPROPRIATE WRAPAROUND SUPPORTIVE SERVICES TO FAMILIES THAT HAVE A DISABILITY THAT PREVENTS THEM FROM LIVING INDEPENDENTLY AND AFFORDING MARKET RENT. HEAD OF HOUSEHOLDS PAY 30% OF THEIR TOTAL HOUSEHOLD INCOME TOWARDS MONTHLY RENT AND THE REMAINING RENTAL AMOUNT IS SUBSIDIZED THROUGH THE DISTRICT OF COLUMBIA HOUSING AUTHORITY VIA THE DEPARTMENT OF HUMAN SERVICES. THC ALSO PROVIDES CASE MANAGEMENT SERVICES THROUGH THE HUD HOMELESS PREVENTION RAPID RE-HOUSING PROGRAMS (HPRP) THAT PROVIDES INTERVENTION SHORT TERM RENTAL ASSISTANCE AND SUPPORTIVE SERVICES TO FAMILIES THAT ARE AT RISK OF LOSING THEIR HOUSING AND/OR RE-HOUSING SERVICES FOR THOSE FAMILIES THAT ARE HOUSED AND CAN NO LONGER AFFORD TO PAY THEIR RENT BECAUSE OF LOSS OF INCOME OR OTHER VARIABLES, AS WELL AS APPROPRIATE SUPPORTIVE SERVICES
