The Oromo House that was purchased in 2008 with contributions by community members and bank loan, is the center where the Oromos living in D.C., Virginia and Maryland meet and discuss how to manage problems they encounter and opportunities available to them. In 2019 health awareness forums were conducted by the International Oromo Health Professionals Association members and DC Government Health Department at this center. Many members of the community were benefited from them. The youth group occasionally meet at this center and learn their heritage and culture that contribute to their healthy development. The church on the second floor is indispensable. It helps in paying the mortgage.

The Oromo Community Organization helped members who needed immigration support by providing them with supporting letters and recommending immigration lawyers who are familiar with the Oromo situation in Ethiopia. Helped many in job search in preparing resumes, giving them support letters and pointing to them useful job search websites. These services are provided by volunteers free with no expense to the organization.

The Oromo Community Organization provided all sorts of support to the community members and families in need by asking members to contribute money directly to those members who lost job or became sick.
