CNHEDs nationally recognized Housing For All Campaign generated the political will for the District to invest more than \$1 billion for the Housing Production Trust Fund from FY2001 through FY2017. To date this has resulted in the acquisition, production, or preservation of more than 10,000 affordable homes with over 3,000 homes in the pipeline. On the Economic Development CNHED provided technical assistance to the Council in crafting the Districts first Low Income Housing Tax Credit, which was funded at \$1 million annually, though is awaiting regulations to be implemented. CNHEDs advocacy resulted in the appropriation of \$14.5 million included in the 2010-2016 budgets for Small Business Technical Assistance. These funds are used to assist up to 3,000 small businesses annually.
