CNHED administers the DC Landlord Partnership Fund, which incentivizes landlords of families or individuals who are exiting homeless and receive rental assistance through certain DHS programs. Other CNHED programs include the Housing for All Campaign, which won a \$100 million annual baseline commitment to the Housing Production Trust Fund. In the past four budgets, the persistence of the campaign, nearly \$480 million was won for affordable housing, and Council has passed three pieces of legislation improving rent control.
