SINCE 2000 NPCDC HAS DEVELOPED 382 UNITS OF AFFORDABLE RENTAL HOUSING IN THE DISTRICT OF COLUMBIA AS WELL AS A 56 UNIT MIXED-INCOME CONDOMINIUM PROPERTY IN COLUMBIA HEIGHTS, WHICH INCLUDES 20,000 SQUARE FEET OF COMMERCIAL SPACE. NPCDC HAS ALSO PARTICIPATED IN DEVELOPING HOMES IN CONJUNCTION WITH THE CITY SPONSORED PROGRAM.
