Urban Hands is an extensive service and education program for volunteers and out-of-town mission groups. City Gate works with 20-25 groups annually, involving over 600 volunteers, with most groups coming for one week.

City Gate runs an out-of-school time program designed to improve student academic performance and provide enrichment activities. It is the goal of City Gate to provide a positive learning environment for students in low income communities.
