IN FISCAL YEAR 2020 GWUL, IN PARTNERSHIP WITH DOEE ASSISTED 9 SINGLE FAMILY HOUSEHOLDS AND 5 APARTMENT BUILDINGS & CO-OPS IN DECREASING HOUSING COSTS AND BECOMING ENERGY EFFICIENT THROUGH THE WEATHERIZATION PROGRAM. THE LEAGUE DISBURSED \$448,693 TO WEATHERIZE HOMES THROUGH THIS PROGRAM. ADDITIONALLY, THE LEAGUE PROVIDES A SUITE OF HOUSING COUNSELING SERVICES IN PARTNERSHIP WITH THE DC DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, THE NATIONAL URBAN LEAGUE, AND CAPITAL ONE BANK. GWUL'S ENTREPRENEURSHIP ASSISTANCE INCLUDES SMALL BUSINESS DEVELOPMENT; FINANCIAL AND CREDIT COUNSELING; FACILITATION OF ACCESS TO CAPITAL; EXECUTIVE BUSINESS MENTORSHIP, INCLUDING NETWORKING OPPORTUNITIES; AND BUSINESS LICENSING ASSISTANCE. IN FISCAL YEAR 2020 THE ENTREPRENEURSHIP CENTER SERVED 382 ENTREPRENEURS.
