IN THE EVENT OF A SALARY CHANGE THE PRESIDENT AND CEO'S SALARY IS REVIEWED AND APPROVED FIRST BY THE EXECUTIVE COMMITTEE OF THE BOARD AND THEN IN THE FULL BOARD. THE BOARD USES COMPARABLE SALARY INFORMATION TO DETERMINE THE SALARY AND BENEFITS FOR THE PRESIDENT AND CEO. THE PRESIDENT AND CEO APPROVES ALL OTHER SALARIES UP TO \$99,999.
