

United Way's community building efforts are focused on generating and providing our community with resources to build local support for human needs. The resources we contribute to our local community are funding, services, volunteers, information & referral, in-kind donations collaborations, ideas, and more. Highlights for the fiscal year ending June 30, 2016 include:

1. As an adjunct to the statewide/regional 211 system, our office receives and handles numerous information and referral calls, walk-ins, and and emails. These requests com from individuals, families, agencies, businesses, etc. seeking help on where to find help or how to access help.

2. Our annual sponsorship and coordination of Stuff the Bus helps qualifying children & youth be ready for the start of a new school year with a new backpack of school supplies and confidence. We work with local businesses and the general public to collect school, organize them, and disburse them in elementary, middle and high schools in Montgomery and Floyd counties, and Radford City.

3. UWMRF provides an Emergency Food Pantry for individuals/families in crisis that cannot or have not been helped by any other food part and are in crisis need of food and/or toiletries. We also provide limited supplies of baby formula, food, and diapers when in stock. While families are in the office, UWMRF also provides guidance on other food resources, and inquires if any other assistance is needed and provides information or guidance on how/where those resources can be accessed as well.

4. Distributes FamilyWise Prescription discount cards though local schools, doctor offices, clinics, health agencies, businesses, and genera community. Saves local people and families hundreds of thousands of dollars each year; tracked benefits.

5. Holiday Meal Assistance Program - Coordinate with general public, community organizations, and businesses to collect turkeys, hams, and food to assemble holiday food boxes. Eligible families and individuals receive a Thanksgiving or Christmas meal package/box with all the holiday essentials including a turkey or ham (or gift card to purchase one). Families take home the food and prepare their very own home-cooked meal without the extra expense burden.

6. Elves United is a program that matches local churches, companies or groups with families in need of major assistance due to a critical family emergency in the past year. Emergencies typically include one or more of the following: the loss of a home through disaster, major medical issue, abandonment, and other serious extenuating circumstances. Each case is referred to UWMRF by Social Service department or other outreach organizations that work closely with families. Families are fully served and receive household items, clothing, food, and other gifts.

7. Toys From the Heart is a large collaborative effort coordinated by UWMRF. It is an Emergency Assistance program that provides gifts to children & youth ages 18 and under (or with an intellectual disability) who have not been served by other local Christmas Assistance
