PEOPLE WITH DISABILITIES ENGAGE IN INDIVIDUALIZED LEARNING AND DEVELOPMENT, VISIT AREA ATTRACTIONS, VOLUNTEER REGULARLY, AND ATTEND COMMUNITY EVENTS. - VERSABILITY'S EARLY PREVENTION AND INTERVENTION FOR CHILDREN (EPIC) PROGRAM ASSISTS INFANTS AND TODDLERS WITH DEVELOPMENTAL DISABILITIES AND DELAYS IN HAMPTON AND NEWPORT NEWS BY ASSESSING THEIR NEEDS AND COORDINATING TAILORED THERAPY PROGRAMS SO EACH CHILD REACHES THEIR POTENTIAL. FAMILIES ARE CONNECTED TO THERAPISTS, EARLY CHILDHOOD EDUCATORS, PARENTING CLASSES, PLAYGROUPS, AND INDIVIDUAL COUNSELING AS NEEDED. EPIC STAFF PROVIDE SERVICES IN THE HOME AND DAYCARE SETTINGS TO TEACH PARENTS THE TECHNIQUES THEY NEED TO CONSTANTLY REINFORCE THEIR CHILD'S DEVELOPMENT WITH THE TOOLS THEY HAVE AVAILABLE.
