Firefly Cafe & Bakery, a warm and friendly, community based, fast-casual restaurant, was launched in March of 2015 This social enterprise was started to create a training venue for individuals with disabilities and/or other significant barriers to employment who want to learn aspects of the food service industry, including dishwashing, bus-person, counter help, food preparation, line cook and baker Firefly has already graduated several successful candidates and placed them in competitive community businesses, and we anticipate at least 10 placements in the year ahead The community has whole-heartedly supported this business, including a visit from Governor McAuliffe and many of our local representatives

The NWW Works organization had another successful year, serving over 235 clients with a wide range of disabilities Highlights include moving over four million half-gallons of milk for HP Hood, at a fully integrated site with all employees making \$7.25 or higher, expansion of our partnership with Fortessa Tableware Solutions to include both on and off site work for our employees, expansion of our duties at community based enclaves including New World Pasta, Kingspan, and Berryville Graphics, a continued partnership with Newell-Rubbermaid that puts dozens of individuals with disabilities to work every day, and new software and accounting systems to better track payroll, client outcomes and cost centers for the organization

In 2015-2016, NWW completely revamped the Socialization Program This redesign of the socialization program saw us moving from a primarily in-facility model to that of a community-based model With 12 clients in the program for most of the year, clients volunteered off site, attended chair yoga classes, went on educational field trips, and visited friends in the community This is a part of a sweeping change in which we are positioning the NWW agency to become more community based and to create a fully integrated atmosphere
