 Cornerstones was founded in 1970 by six religious organizations in Reston with a mission to make affordable housing more accessible to Reston-area residents. Since then, the organization has grown into a leading social services provider, serving more than 15,000 unduplicated people a year in Fairfax County by helping neighbors in need overcome tough economic times or other challenges in an already high cost-of-living region. Through advocacy and support services, Cornerstones connects people in Northern Virginia to the vital resources they need to build more stable families and self-sufficient lives and provide a comprehensive array of programs that solve urgent or on-going requirements for housing, childcare, food or financial assistance.

Our Affordable Housing Development, Preservation, and Asset Management program oversees the 105 affordable units owned by our affiliates, Cornerstones Housing Corporation and RIHC Partners, LP, which housed 110 households and 303 individuals in FY17. Cornerstones Housing Corporation owns a scattered site housing program consisting of 49 town homes and 8 condo units. RIHC Partners, LP owns The Apartments at North Point, a 48 unit apartment complex. Our affiliates own these units to assure that they will remain affordable for a range of low to moderate income households. Connections for Hope Partnership is a collective effort of nonprofit, government, school and community partners providing integrated health and human services for low-income children, youth and adults. C4HP brings together community service organizations, both public and private, that have committed to share resources, services and work space in order to improve outcomes for low-income families and individuals. In FY17, C4HP services benefited 888 adults and children. A total of 420 individuals participated in housing counselor and home buyer education workshops offered through our Housing Counseling program. Of this total, 70 also participated in the foreclosure prevention program.
