**1** Briefly describe the organization's mission or most significant activities  
Named the 2018 Nonprofit of the Year for "outstanding and visionary contributions to the community" by the Northern Virginia Chamber of Commerce, Cornerstones takes a multi-pronged approach to addressing poverty in the otherwise affluent region of northwestern Fairfax County. Cornerstones was also chosen this year by Visit Fairfax to be its nonprofit partner for "LoveShare", the tourism industry's first countywide corporate social responsibility program. Established in 1970 by six faith communities in Reston, with a mission to make housing more affordable for low-income residents, Cornerstones has since grown into a leading social services provider helping over 16,000 residents a year obtain or maintain stability, partnering with over 6,000 volunteers and key providers in the community to improve equitable access to other resources and opportunities, and advocating for critical systems change needed to address root causes of poverty in the community.

 Cornerstones Housing Corporation owns a scattered site housing program comprising 49 town homes and eight condo units RIHC Partners, LP owns The Apartments at North Point, a 48-unit apartment complex These Cornerstones' affiliates bought these units to ensure they remain affordable for a range of low- to moderate-income households Cornerstones' Affordable Housing Development, Preservation, and Asset Management program oversees all these units which last year housed 110 families (comprising 303 individuals), all of whom were provided care management services to improve the families' stability Connections for Hope Partnership (C4HP) is a collective effort of nonprofit, government, school and community partners providing integrated health and human services for low-income families and individuals C4HP brings together community service organizations, both public and private, that have committed to share resources, services, and work space in order to improve outcomes for low-income families and individuals In FY18, C4HP services benefited 1,143 adults and children Cornerstones runs a Pathways to Sustainable Employment program at C4HP which helps low-income clients address barriers to obtaining or improving employment Last year 57 clients who engaged in these services found or improved employment The Citizenship Classes offered by Cornerstones have helped 139 individuals from 28 countries become citizens of the United States of America as of June 30, 2018 The Housing Counseling program supports low-income home-owners and potential home-buyers Last year a total of 124 individuals participated in housing counseling and home buyer education workshops Twenty-eight of the families reset their mortgages to avoid foreclosure and eight additional families purchased a home
