Stability services provide vital support to vulnerable neighbors in time of crisis, meeting critical human needs. Cornerstones offers swift triage and vital support to our most vulnerable neighbors. We provided outreach, shelter and supportive services for 770 individuals, including 135 children and 28 chronically ill individuals, in addition to rapidly re-housing people in permanent housing. With financial aid and counseling, we prevented evictions for 186 struggling households. To avert financial crisis and offset the high cost of living, we provided food, diapers and household supplies to 6,567 individuals, including almost 3,000 children.

Empowerment services offer wrap-around resources to help families and individuals thrive in their communities. Laurel Learning Center [LLC] provided quality care and social/academic support to 221 children, from age 6 weeks to 12 years old. LLC enables low-income parents to work while their children are in a safe, stimulating and affordable environment. Cornerstones offered additional out-of-school enrichment programs in the community that helped 88% of children attending improve their math and reading grades. We counseled 285 local households facing financial hardships, connecting them to resources and services. Our Job Readiness and Employment service graduated 78 people, while adult education helped 237 individuals improve their English and/or take Citizenship classes. Cornerstones also operates 108 affordable housing units, owned by our subsidiary, which are covered under separate IRS forms.

Driving change includes engaging and amplifying the voices of our low-income neighbors. In addition, we provided organizing support in low-income housing communities to help residents improve their environment and access needed services.
